
BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

A BILL FOR AN ORDINANCE AMENDING THE NORTHGLENN MUNICIPAL CODE BY THE ADDITION OF NEW SECTION 9-9-5 PROHIBITING THE USE OF FLAMMABLE GAS TO EXTRACT "THC"

WHEREAS, C.R.S. § 9-7-113 provides that local governments may ban the use of compressed flammable gas as a solvent in the extraction of THC or other cannabinoids in a residential setting;

WHEREAS, Colorado has experienced a surge in home explosions resulting from residential THC extractions involving compressed flammable gasses;

WHEREAS, pursuant to the specific authority granted to the City in C.R.S. § 9-7-113, and in the interests of the health, safety and welfare of the City's residents, the City Council desires to prohibit the use of compressed flammable gases in THC extraction.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:


Section 1. The Northglenn Municipal Code is amended by the addition thereto of a new Section 9-9-5 to read as follows:

**Section 9-9-5.** Use of Flammable Gas to Extract THC. The use of flammable gas as a solvent in the extraction of tetrahydrocannabinol ("THC") or any other cannabinoid is prohibited within any residential structure in the City.


