distance from the business to the nearest residential property, and investments and improvements made to the business.

Attorney Hoffmann provided information regarding distance requirements for marijuana businesses, the existing premises' conformance with the regulations prior to and after the adoption of new regulations, and the proposed expansion's non-compliance with the current distance restrictions. Attorney Hoffmann spoke regarding Council's authority and options to either approve or deny the application based on their determination, and provided information about a discrepancy between the State and City regarding the licensed premises of the business.

There was discussion regarding the modification of premises application, the proximity of the proposed expansion to the nearest residential property, marijuana business regulations, and holding a public hearing on the application.

Attorney Hoffmann stated the current ordinance does not contemplate a hearing on a modification of premises application, but stated the application could be continued to a date certain to allow for notice to be given and a public hearing to be held on the application.

MOTION TO PASS

Council member Whitman **MOVED** and it was **SECONDED** by Council member W. Dodge to continue the modification of premises application filed by BotanaCare, LLC, to set a public hearing on the application for June 8, 2015, and to provide notice of the hearing in accordance with the Northglenn Municipal Code.
