A BILL FOR AN ORDINANCE AMENDING THE PENALTY PROVISION OF THE CITY OF NORTHGLENN MUNICIPAL CODE TO ALIGN WITH STATE LAW REGARDING THE MAXIMUM CRIMINAL PENALTY THAT CAN BE IMPOSED FOR CERTAIN VIOLATIONS OF THE NORTHGLENN MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

Section 1. Section 1-1-10 of the Northglenn Municipal Code is hereby amended by the addition thereto of a new Subsection (a)(4) to read as follows:

Section 1-1-10. General Penalty -- Continuing Violations.

(a) Whenever by any ordinance of the City of Northglenn any act is prohibited or declared to be unlawful or an offense, or a misdemeanor, or the doing of any act is required, or the failure to do any act is declared to be unlawful or an offense, or a misdemeanor:

(4) ANY PENALTIES IMPOSED BY THIS CODE MAY NOT EXCEED THE MAXIMUM PENALTIES ESTABLISHED BY SECTIONS C.R.S. § 18-1.3-501(1)(A.5) AND C.R.S. § 18-1.3-503(1.5), OR ANY SUCH APPLICABLE LIMITATION OTHERWISE SET BY STATE LAW.
