Unfortunately, that has not been my experience. I work at a psychiatric stabilization unit and have interacted with Northglenn officers during emergency calls on numerous occasions over the past five years. Rather than feeling supported as healthcare professionals responding to mental health crises, my colleagues and I have often been made to feel as though we were inconveniencing officers by requesting assistance. Mental health emergencies are complex, stressful, and often require collaboration between healthcare providers and law enforcement. In my experience, interactions with Northglenn officers have frequently felt dismissive, invalidating, and lacking in empathy toward both staff and the vulnerable individuals we serve. I recognize that police officers face difficult and demanding situations every day. However, if the department truly values building trust within the community, there is significant room for improvement in how officers engage with mental health professionals and people experiencing psychiatric crises. Respect, professionalism, and collaboration should be the standard in these situations. Unfortunately, that has not been my experience. Myself and staff do not feel protected or valued, and there needs to be a change.
