Mr. Chris DeMay, Northglenn Community Foundation, was present and spoke regarding the nature of the event. Mr. DeMay indicated that the event is being hosted in conjunction with the Colorado State Harley Owners Group. Monies raised will be used to fund grants for Northglenn senior citizens that are having difficulty paying their Northglenn utility bills. Mr. DeMay spoke regarding the layout of the event and indicated that wristbands will be issued to all attendees of the event, with different colors being issued to minors. There will also be spot checks of identification to ensure that no underage persons have access to alcoholic beverages. Mr. DeMay stated that all alcohol will remain within the perimeter controlled area; persons wishing to go to the playground or leave the event will be instructed to dispose of alcohol before exiting. Mr. DeMay indicated that off duty Northglenn Police Officers and Adams County Deputies will provide security for the event. Additionally, North Metro Fire Rescue District will have a first aid booth at the event.
