#### **BACKGROUND:**

The Management Services Department is organized into three (3) divisions which include: Municipal Court, Human Resources and Community Engagement. The Municipal Court has jurisdiction over all cases involving violations of the provisions of the City Charter, code and other ordinances of the city. Human Resources is responsible for recruiting, retaining, and training Additionally, Human Resources coordinates and administers employee benefits, including worker's compensation, manages employee relations, and supports overall organizational development. The Community Engagement Division creates connections and provides involvement, interaction and problem resolution through volunteer services, community outreach, neighborhood programs, events, and proactive relations with residents.
