 - Complete 2009 CAFR by June 15, 2010
 - Present budget preparation schedule by May, 2010
 - Discuss 2011 budget priorities with City Council by May 2010
 - Adopt 2011 budget by October 28, 2010
- Continue implementation of financial management system, substantially complete by December 31, 2010
- Initiate discussion with Council regarding two, 0.5% sales taxes scheduled to sunset on 12/31/2010
- Conduct a complete review of the Financial Policies and Procedures
- Prepare and issue RFP's for external audit and banking services
- Provide accurate & timely financial information to City Council and Public
- Actively pursue local, state and federal grants

II. MAINTAIN AND IMPROVE CITY INFRASTRUCTURE & FACILITIES

- Reconstruct Huron Street from 112th to 104th using ARRA funding
- Complete design and begin construction of Skate Park Facility
- Implement 2010 Street reconstruction and rehabilitation program consistent with the voter approved 4 mill property tax extension
- Complete Wastewater Treatment Plant Master Plan. Establish plan for improvements and identify funding sources
- Finalize an action plan for the Northglenn Recreation Center to bring it into compliance with applicable Building and Fire Codes
- Conduct Energy Audit for City Hall, Recreation Center, Water Treatment Plant and Wastewater Treatment Facility
- Establish a more comprehensive capital repair & preventative maintenance program for City buildings: City Hall, Police Department, Recreation Center, Maintenance and Operation, and Kiwanis Pool. Review options for funding sources

III. ENHANCE AND SUPPORT CITY UTILITY AND ENTERPRISE ACTIVITIES

- Complete transition to fully automated trash collection system
- Adopt a business plan for single stream curbside recycling program
- Develop options for green waste disposal/composting
- Review and adjust water and sewer rates as needed on an annual basis

- Respond to Thornton's request to amend 1992 Settlement Agreement
