

A BILL FOR AN ORDINANCE ESTABLISHING A RESIDENCY REQUIREMENT FOR THE CITY MANAGER

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

Section 1. Section 2-3-1, subsection (b) of the City of Northglenn Municipal Code is amended to read as follows:

(b) The City Manager shall be selected solely on the basis of his administrative qualifications with special reference to training and experience. For a City Manager appointed after the effective date of this ordinance, within twelve (12) months following his or her appointment, the City Manager shall be required to reside within the limits of the City. PROVIDED, HOWEVER, THE CITY COUNCIL MAY EXERCISE ITS DISCRETION TO CONTRACTUALLY AUTHORIZE RESIDENCY OUTSIDE OF THE CITY LIMITS IF SUCH CITY MANAGER RESIDES AT A REASONABLE DAILY COMMUTING DISTANCE BY AUTOMOBILE FROM THE CITY AT THE TIME OF APPOINTMENT.


