A BILL FOR AN ORDINANCE AMENDING SECTION 3-3-3, SUBSECTIONS (a) AND (b) TO CONFORM WITH AMENDMENTS TO THE CITY OF NORTHGLENN HOME RULE CHARTER AS APPROVED BY THE REGISTERED ELECTORS OF THE CITY OF NORTHGLENN

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

Section 1. Section 3-3-3, subsections (a) and (b) of the City of Northglenn Municipal Code are amended to read as follows

Section 3-3-3. Meetings.


(a) Regular Meetings - The City Council shall meet in regular council sessions for business at least twice each month at a day and hour to be fixed by rules of Council. The Council shall determine the rules of procedure governing meetings. The first meeting, following THE CERTIFICATION OF ELECTION RESULTS FOR each general municipal election ~~in January next following election,~~ shall be the organizational meeting of the Council, AND THE COUNCIL MAY ALSO CONSIDER ANY OTHER BUSINESS AT THE ORGANIZATIONAL MEETING.

(b) Special Meetings - Special meetings shall be called by the City Clerk on the written request of the Mayor or of any two members of the Council, or the City Manager, on at least 24 hours written notice to each member of Council, served personally or left at his usual place of residence, OR BY ANY MEANS DETERMINED BY THE COUNCIL TO PROVIDE ADEQUATE NOTICE.

(1) A special meeting, however, may be held on shorter notice if a quorum of the Council consents.

(2) No business shall be transacted at any special meeting of the Council unless it has been stated in the notice of such meeting. Any other business which may lawfully come before a regular meeting other than that for which a special meeting was called may be transacted at a special meeting if all the members of Council who are present, consent.


