#### **COMMUNICATIONS:**

Legal Memorandum -Good Cause for Non-Renewal

Mr. Hoffmann, attorney for the Authority, presented a legal memorandum dated September 20, 2010 to the Authority regarding the finding of "good cause", as defined by C.R.S. § 12-47-103(9)(a), for non-renewal of an existing liquor license. Mr. Hoffmann cited recent case law that sets a less stringent standard for non-renewal of a liquor license, as opposed to revocation or the imposition of sanctions against a licensee. Mr. Hoffmann indicated that non-renewal of an existing liquor license is based upon two factors: the severity of an act that violates the Liquor Code and whether the licensee had "actual or constructive knowledge" of the act. Mr. Hoffmann also discussed the hearing process, the findings of fact and issuance of a decision.
