A RESOLUTION APPOINTING THE MUNICIPAL JUDGE OF THE CITY OF NORTHGLENN, COLORADO

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

Section 1. Pursuant to Section 6.11(b) of the City Charter of the City of Northglenn and Section 8-1-4(b) of the City of Northglenn Municipal Code, Corinne Magid is hereby appointed the Municipal Court Judge of the City of Northglenn to complete the current term expiring on January 31, 2019.

Section 2. The Municipal Judge Salary shall be as set forth in the Agreement attached hereto as **Exhibit A**, and incorporated herein by this reference, and the Mayor is authorized to execute the same on behalf of the City.

## **AGREEMENT**

THIS AGREEMENT is made and entered into this \_\_\_\_\_ day of February, 2018, by and between the City of Northglenn, a Colorado home rule municipality (the "City"), and CORINNE MAGID ("Judge Magid").

### **RECITALS:**

The City Council has previously determined to appoint Judge Magid as the Municipal Judge of the City of Northglenn pursuant to Section 6.11(b) of the City of Northglenn Home Rule Charter and Section 8-1-4(b) of the City of Northglenn Municipal Code, and desires to set the salary of Judge Magid pursuant to the above-referenced provisions.

NOW, THEREFORE, it is hereby agreed that, for the consideration hereinafter set forth, the appointment of Judge Magid as Municipal Judge of the City of Northglenn shall be continued as follows.

### **I. TERM**

Judge Magid's appointment is hereby extended to January 31, 2019 as Northglenn Municipal Judge.

### **II. COMPENSATION**

Pursuant to Section 6.11(b) of the City of Northglenn Home Rule Charter and Section 8-1-4(b) of the Northglenn Municipal Code, the monthly fixed salary shall be four thousand seven hundred seventy dollars (\$4,770.00). In addition, the City shall pay the cost of training in an amount not to exceed \$1,000 per calendar year and shall pay the cost of Colorado Supreme Court attorney registration dues in an amount not to exceed \$400 per year.

### **III. OTHER COVENANTS**

Judge Magid's job performance, salary and other contractual issues, if any, shall be reviewed by the City Council prior to the date of re-appointment for a new term, or prior to January 31, 2019, and every two (2) years thereafter.

### **IV. COMPLIANCE WITH LAW**

Nothing herein shall be deemed to create any additional terms, conditions or obligations of employment in addition to those provided for in the City of Northglenn Home Rule Charter and the City of Northglenn Municipal Code, nor is anything herein intended to change the nature of the Municipal Judge position as an appointed position under the City of Northglenn Home Rule Charter and the City of Northglenn Municipal Code; rather, this Agreement is simply intended to memorialize the term and salary of the Municipal Judge as required by the applicable law.
