### Northglenn Commercial Real Estate

Listed below is a summary of the available Northglenn office, industrial and retail space as of December. The chart depicts that both office and industrial vacancies have remained relatively stable throughout the year. However, we have seen an increase in the retail vacancies in 2012. Besides Big Lots and Borders that closed earlier this year, there have been three new major vacancies reported since third quarter. That includes the closure of Old Navy with 34,382 square feet, a new 7,200 square foot sub-lease in the Office Depot building, and the addition of two new retail buildings which include Karl's Farm Dairy building with 6,000 square feet, and 30,000 square feet at 6950 W. 106<sup>th</sup> Avenue (former Northglenn Dodge Collision Center). The current 17.3% vacancy rate is almost 80 percent higher than it was in the first quarter of 2010 (9.6%).

### Unemployment

### Urban Renewal Plan Update

Staff worked with the consultant to finalize the URA condition study, county impact reports, proposed amendment to URA Plan 1, and proposed URA Plan 2. All tenants, property owners, county, and districts were notified by mail. A study session with council was held on November 19<sup>th</sup> to provide an update on the process. Additionally, staff and the consultant met with the Planning Commission on November 20<sup>th</sup> to update them on the proposed Plans and conformity with the Master Plan.

The December 17<sup>th</sup> public hearing will be held at 7 PM in the city council chambers. The purpose of the hearing will be to have City Council consider the recommendations from the Northglenn Urban Renewal Authority to:

- Determine that certain real property within the City of Northglenn constitutes a “blighted area”;
- Approval of a substantial modification to the current Northglenn Urban Renewal Plan (#1) by the removal of certain property from the current Northglenn urban renewal area; and
- Approval of a new Urban Renewal Plan (#2)

### **Northglenn Becoming a Leader in STEM Education**

Staff has been meeting over the past month with members and staff from the Northglenn STEM (Science, Technology, Engineering, and Mathematics) teams. A committee has been developed to help build stronger partnerships within the business community to enhance the student’s learning experience by working with companies in real world situations.

Adams 12 Five Star school district has the only comprehensive K-12 STEM (Science, Technology, Engineering and Mathematics) continuum in the state that allows students to attend a STEM school from K-12. Northglenn students can begin their STEM education as early as kindergarten, and follow the program through high school graduation. Students from K-8 can apply to attend the STEM Magnet Lab school located at 117<sup>th</sup> and Irma Drive, or the STEM Launch school at 94<sup>th</sup> Avenue and Pecos Street for grades 6-8. These are both feeder schools into the Northglenn High School (NHS) STEM programs.

NHS’s curriculum includes pathway classes in engineering, biomedical, college preparatory (CP), advanced placement (AP), and advanced elective (AE) classes. Classes include engineering principals in aerospace, biotechnical, civil and architecture, computer integrated manufacturing, digital electronics, and design and development. Within the biomedical program they include biomedical sciences, human body systems, medical interventions, and biomedical innovation. Students can customize their programs to include the AP, AE and CP classes to maximize their college opportunities and individual interests.

Next month NHS will open its new 16,000 square foot state-of-the-art STEM facility. The new space is uniquely designed to accommodate 75 students within each classroom. The facility includes a 3D printer that can be used to produce engineered design prototypes, two clean rooms and a large presentation area. NHS has approximately 1,750 students, and within the next year all the students will be enrolled in STEM-related programs. During this transition NHS will change its name to Northglenn High School STEM. These programs uniquely position Northglenn as an incubator for future STEM-related workforce leaders of tomorrow. Northglenn students are being educated and prepared for college, as well as groomed to be successful in future STEM-related careers.
