**THIRD AMENDMENT TO AGREEMENT BETWEEN THE CITY OF NORTHGLENN
AND COREY Y. HOFFMANN, ATTORNEY AT LAW**

THIS THIRD AMENDMENT TO AGREEMENT, made this _____ day of _____, 2016, to be effective _____, by and between COREY Y. HOFFMANN of Hoffmann, Parker, Wilson & Carberry, P.C. (hereinafter "First Party"), and the CITY OF NORTHGLENN, COLORADO (hereinafter called the "Second Party" or the "City").

WHEREAS, on October 12, 2006, the City Council approved the Assignment of that Agreement for legal services dated June 12, 2003 (the "Original Agreement") from Herbert C. Phillips to Corey Y. Hoffmann;

WHEREAS, the parties further amended the Original Agreement by First Amendment approved February 28, 2008;

WHEREAS, the parties entered into a Second Amendment approved April 2, 2009; and

WHEREAS, the parties desire to amend Section 7 of the Original Agreement regarding the hourly rate paid for such legal services.

NOW, THEREFORE, the parties agree to amend Section 7 to read as follows:

7. Effective January 1, 2017, Second Party shall pay First Party at an hourly rate of ~~\$165.00~~ \$185.00, payable in monthly installments.

Except as amended above, the provisions of the Original Agreement, the First Amendment and the Second Amendment remain in full force and effect and are hereby ratified by the First Party and the Second Party.
