AMF Northglenn

Deputy City Clerk Andrews advised the Authority that AMF Bowling Centers, Inc. has withdrawn a report of changes to register Mr. Joseph Ulibarri as the new on-site manager of AMF Northglenn. As the application is withdrawn, no further Authority action is required.

LIQUOR LICENSE RENEWAL APPLICATIONS:

El Mirador

Deputy City Clerk Andrews advised the Authority that El Mirador, Inc. has submitted an application for renewal of the liquor license held for the establishment known as El Mirador. The application is not eligible for administrative approval due to derogatory information pertaining to the potential conduct of the establishment within the last year. Of specific concern, Northglenn Police Department reports a D.U.I. arrest in the parking lot of the establishment on August 9, 2015. According to a witness account, the driver had been seen drinking "several alcoholic beverages inside the restaurant" and "walking out of the restaurant, stumbling."

The application for renewal was initially considered at the April 18th meeting of the Northglenn Liquor Licensing Authority. The matter was continued to May 2nd so the licensee could be advised of the Authority's concern and have the opportunity to be present to discuss the matter.

Mr. Javier Hernandez and Mr. David Leon were present on behalf of El Mirador, Inc.

Deputy City Clerk Andrews advised that a letter was received from Oedipus, Inc. regarding recent TIPS training held at the

> establishment. Training materials and updated certificates of completion were provided for the licensee and all employees.

> There was Authority discussion regarding El Mirador, Inc. obtaining TIPS training and maintaining certification for all employees as a means of addressing the Authority's concern.

Vice Chairperson Whitman **MOVED** and it was **SECONDED** by Ms. Mikan to approve the liquor license renewal application filed by El Mirador, Inc. d/b/a El Mirador.

Northglenn Discount Liquor Deputy City Clerk Andrews advised the Authority that SRK Corporation has submitted an application for renewal of the liquor license held for the establishment known as Northglenn Discount Liquor. The application is not eligible for administrative approval due to derogatory information pertaining to the potential conduct of the establishment within the last year. Of specific concern to the Authority are the following: a delinquency on the licensee's business and sales tax account with the City of Northglenn; a Northglenn Police Department report regarding theft of alcohol from the establishment on May 6, 2015; and a liquor code violation which occurred on February 5, 2016 involving the selling, service, giving, or procuring of an alcohol beverage to a minor. The violation was adjudicated through the State of Colorado Liquor Enforcement Division and a copy of the Stipulation, Agreement and Order was previously provided to the Authority.

> The application was initially considered on April 18th but continued to May 2nd so the licensee could be advised of the Authority's concerns and have the opportunity to be present to discuss the matter.

No one was present on behalf of SRK Corporation.

Deputy City Clerk Andrews stated that the business and sales tax account has been brought into good standing since April 18th and the account is now current.

Deputy City Clerk Andrews also stated that the licensee was advised of the Authority's concerns and invited to attend the May 2nd meeting via certified mail. If the Authority wishes to continue the matter to May 16th, further attempts will be made to contact the licensee.
