Applebee's Neighborhood Grill and Bar Deputy City Clerk Andrews advised the Authority that Apple Colorado, LLC d/b/a Applebee's Neighborhood Grill and Bar has submitted a report of changes to register Mr. Amedeus Rosedale as the new on-site manager. Information was also provided regarding the background investigation that was conducted on Mr. Rosedale and his disclosure of arrests in 2008 and 2014.

Food Truck Carnival Deputy City Clerk Andrews provided information about the application for a special events permit submitted by Northglenn

Community Foundation for The Food Truck Carnival to take place at Northglenn City Hall, west parking lot, on May 13-15, 2016.

Mr. Steven Stokes, Event Supervisor, was present on behalf of City of Northglenn. Mr. Stokes advised the Authority that all members of Northglenn Community Foundation, the applicant, have been TIPS trained and the event will be managed in the same manner as the 2015 Pirate Fest.

Ms. Leslie Carrico was present on behalf of Northglenn Community Foundation. Ms. Carrico stated there will be volunteers and at least three (3) TIPS trained members staffing the event at all times. The event will feature amusement rides, food trucks, and three different beverage distributors.

Mr. Stokes spoke regarding the event perimeter and stated wristbands and drink tickets will be utilized to control the consumption of alcohol at the event. Identification will be checked before the issuance of a wrist band. The event is scheduled to take place May 12th through May 15th, however, no alcohol will be available on May 12th. The permit is being sought for May 13th, 14th and 15th, 2016.

**LIQUOR LICENSE
RENEWAL
APPLICATION:**

At Cheers

Deputy City Clerk Andrews advised the Authority that Bueno/Kirk, Inc. has applied for annual renewal of the tavern liquor license held for the establishment known as At Cheers. There was discussion regarding the conduct of the establishment and the number of police calls for service within the last year.

Attorney Ryan Malarky advised the Authority regarding criteria for finding “good cause” for non-renewal of the liquor license.

Commander Osgood was present on behalf of Northglenn Police Department. There was discussion regarding the number of police calls for service at the establishment within the reporting period. Commander Osgood stated not all 49 calls for service can be attributed directly to the establishment due to the location in a shopping center complex comprised of several other businesses and a large parking lot. Commander Osgood noted that all conditions of the stipulation, agreement, and order regarding the 2015 renewal of the tavern liquor license have been met. The establishment has been able to provide video surveillance on several occasions to assist in police investigations. Commander Osgood stated the licensee appears to be making a legitimate effort to be in compliance and maintain a positive relationship with Northglenn Police Department.

Mr. Robert Kirk was present on behalf of Bueno Kirk, Inc. Mr. Kirk spoke regarding the new video surveillance system at the establishment; he is able to remotely view and back up recordings from his cell phone. Mr. Kirk stated one bartender has become a certified TIPS trainer and he is working toward improving management of the establishment and maintaining a good relationship with Northglenn Police Department.

Ms. Whitman **MOVED** and it was **SECONDED** by Ms. Lawless to approve the liquor license renewal application submitted by Bueno/Kirk, Inc. d/b/a At Cheers.
