Why do you want to be appointed to the City Council?
I have considered running for City Council for some time, as my husband and I plan to live in this community, in our home, through the rest of our lives. I want to be involved in the City of Northglenn’s future; my husband and I love where we are raising our family, and I want to be a part of setting the direction for our community. When we were initially house-hunting in the north metro, we were struck by Northglenn’s unique neighborhoods, and we enjoyed that people spent time in their front yards and waved to us as we biked through the area. We also value the quality of our Perl Mack home. We want to stay here and be part of setting the direction for our neighborhood, and community’s, future.
How will your education, training, experience, and knowledge of the community make you a suitable candidate to serve as a member of the City Council?
I have a Masters of Urban Planning from the University of Michigan, went through half of the Architecture program at Louisiana State University, and have spent the last 9 years working locally with organizations

that promote transportation solutions to congestion. I have served on the RTD Citizens Advisory Committee for nearly two years, and I have worked at a local non-profit, Smart Commute Metro North, since 2016 (currently in a part-time capacity). I am an expert in transportation, particularly transit and active transportation methods. My work over the past 9 years has focused on both local employer outreach as well as resident outreach, and I greatly understand the problems that our local employers, and their commuting employees, face. I have been greatly involved in the North Area Transportation Alliance (NATA) and regularly take minutes for these meetings, so I am familiar with the transportation challenges of both our community and our neighboring communities. I have a keen sense of cooperation and collaboration, along with a great respect for our community's elected officials and the elected officials of our neighboring communities.

In your opinion, what are the most important issues facing the City and how would you propose they be addressed?

I believe there are two significant issues facing the City: one is redevelopment, and the other is transportation.

Redevelopment should be pursued thoughtfully, both with an eye on immediate benefits to the quality of life of our community and the long-term benefits. I think we need to be conscious of negative externalities when we review development proposals, and we should look for pro-active development that aligns with city goals.

I work in the transportation realm, with a particular focus on non-solo-driving modes (transit, biking, walking, teleworking, carpooling, etc.), so I might be a bit biased about the kinds of transportation solutions our community needs. I believe our community needs to be very thoughtful about where we encourage throughput traffic and that we are at a point where we need to strongly encourage other ways to get around. In particular, there are active things that we can do as a city to encourage residents to walk and bike for short, near-home trips. I also think there are things we can encourage at the school-chauffeuring level to reduce drop-off and pick-up traffic in our neighborhoods. I am also concerned about dangerous traffic behavior like speeding, which endangers all people using our transportation system. Finally, I have great concerns about the lack of transit in our community and the lack of RTD services providing service to the Northglenn community (and Ward 1 in particular).

What vision do you have for the City of Northglenn?

I would like to see our community be a place for young and old, for people in vocational careers, and for people looking for a vibrant, people-oriented place. I would love to see neighborhoods where neighbors know each other and where people plan to stay. I would like to see a place where you can get what you need, and where you need to go, without having to find a way to pay for a car.

In reviewing the City's 2020 Budget, what are you most excited about and why?

I think, like most people, I am very excited about the new recreation center, which will be such a good amenity to the community. I am also admittedly excited about the (hopefully soon-to-come) N-Line, and so I'm glad to see that the city is preparing to spend a little money on a community celebration of this long-overdue transit investment by RTD.

If the Council is debating an item that is, for you, a particularly strong emotional issue, how would you maintain your objectivity?

I am an empathetic person and, while I haven't held office, in other settings where emotions ran high I was able to take a step back and listen to all views to better understand where others were "coming from" in their dissenting points. While I listen to others' points of view, I also rely highly on a thorough review of evidence connected to any dissenting points, which either helps me confirm my position or allows me to concede to others' points.
