A Precious Child, Inc.

Deputy City Clerk Andrews provided a summary of the special events permit application filed by A Precious Child, Inc. for Mudapalooza, a mud volleyball tournament, to be held at Northwest Open Space on June 15, 2019 from 8:30 a.m. to 8:30 p.m. A notice was posted on premises for a period of 10 days. The notice stated that any objections to the issuance of the permit must be filed with the City Clerk's Office by 9:00 a.m. on May 20, 2019. No objections have been received.

Ms. Charlene Cram was present on behalf of A Precious Child, Inc. and Mr. Brian Magnett was present on behalf of the City of Northglenn. Mr. Magnett, Recreation Programs Supervisor, stated the event will be managed in the same manner as years past. Identification of all persons entering the event will be checked; wristbands will be issued to those of legal age to consume alcohol. All persons under the age of 21 will have an "X" marked on their hands in permanent marker to ensure they don't consume alcohol.

LIQUOR LICENSE RENEWAL APPLICATIONS

Loyal Order of Moose Lodge #2166

Deputy City Clerk Andrews provided a summary of the liquor license renewal application filed by Loyal Order of Moose Lodge #2166. The application is not eligible for administrative approval due to derogatory information pertaining to the conduct of the establishment within the previous reporting period. Specifically, on October 25, 2018, Northglenn Police Department responded to the establishment regarding a report of severely intoxicated individual. Upon contact, officers determined the individual was too intoxicated to care for himself and he was transported to the hospital for his safety. The bartender on duty was issued a summons for selling or serving alcohol to a visibly intoxicated person and selling, serving, or distributing malt, vinous, or spirituous liquor during prohibited hours. Northglenn Police Department referred the case to the State Liquor Enforcement Division which imposed the following sanctions: a 27 day suspension to be served as 10 days of active suspension, from June 9, 2019 through June 18, 2019, with 17 suspension days held in abeyance for a period of one year during which the Licensee is to have no further liquor code violations. The Licensee was also ordered to pay a fine in the amount of \$1,571.95.

As a separate issue, the State Liquor Enforcement Division also issued a warning letter to the Licensee pertaining to a "coin push" gaming device that was on the licensed premises, in violation of C.R.S. § 44-3-901(6)(n)(I) which regulates gambling devices. The machine was ordered removed from the establishment.

LIQUOR CODE VIOLATIONS

7-Eleven #13188A

On March 11, 2019, Northglenn Police Department conducted a compliance check at the establishment known as 7-Eleven #13188A, 11421 Washington Street. After a minor was able to purchase an alcohol beverage, Harleen Kaur was cited for a violation of Northglenn Municipal Code § 9-8-5: Beer, Wine, and Liquor Sales to a Minor.

Ms. Kaur appeared in Northglenn Municipal Court on April 18, 2019 and entered into a deferred judgement subject to compliance with the following terms and conditions within 90 days: Completion of a TIPS training course, performance of community service, and payment of a deferred judgement fee.

This is the first violation for the Licensee.

High Tide S Liquor

On March 11, 2019, Northglenn Police Department conducted a compliance check at the establishment known as High Tide S Liquor, 11215 Washington Street, Unit B. After a minor was able to purchase an alcohol beverage, Simret Gebremesk Woldeselassie was cited for a violation of Northglenn Municipal Code § 9-8-5: Beer, Wine, and Liquor Sales to a Minor.

Ms. Woldeselassie appeared in Northglenn Municipal Court on April 18, 2019 and entered into a deferred judgement subject to compliance with the following terms and conditions within 90 days: Completion of a TIPS training course, performance of community service, and payment of a deferred judgement fee.

This is the first violation for the Licensee.
