Specifically, the Northglenn Liquor Licensing Authority issued a stipulation, agreement, and order pertaining to a liquor code violation that occurred on October 18, 2018. As of May 6, 2019, the Licensee is in substantial compliance with the terms and conditions of the order after having served 15 active suspension days and paying a fine in lieu of 5 suspension days. An additional 18 days of suspension are being held in abeyance for 2 years pending no further violations.
