## NEW LIQUOR LICENSE APPLICATION – PUBLIC HEARING:

Larkburger of Colorado, LLC

d/b/a Larkburger Chairman

Chairman Hall provided an opening statement for the public hearing on the new license application filed by Larkburger of Colorado, LLC d/b/a Larkburger. There were no objections to the jurisdiction of the Authority or procedure of the hearing. Northglenn Liquor Licensing Authority June 18, 2012

Mr. Tom Blackburn was present on behalf of Messner & Reeves, LLC, Attorneys at Law representing the applicant. Mr. Blackburn asked if there were anyone in attendance that would like to object to the issuance of a beer and wine license to Larkburger of Colorado, LLC d/b/a Larkburger. There was no response.

Mr. Blackburn stated that he would not be making an opening statement but would proceed with examination of witnesses.

Mr. Adam Baker was present on behalf of Larkburger of Colorado, LLC d/b/a Larkburger. Mr. Baker testified under oath that he is the general manager and provided information as to the nature and location of the restaurant, other Larkburger restaurants in Colorado, his professional background, the business structure and finances of Larkburger of Colorado, LLC, previous liquor code violations at the Boulder, Colorado Larkburger restaurant, the company culture and policies with respect to compliance with State of Colorado Liquor and Beer Code, TIPS training, the floor plan of the proposed premises, and the perceived needs and desires of the neighborhood.

Mr. Baker answered questions from the Authority regarding how customers will be served, patio access, the use of card readers and the company policy of checking I.D. of everyone less than 40 years of age.

Ms. Susan Duffy Schwall was present on behalf of Liquor Licensing Professionals, LLC and provided sworn testimony regarding the neighborhood survey that was conducted. Ms. Duffy Schwall stated that 93% of those residents and businesses surveyed expressed support for the application, demonstrating a strong neighborhood need and desire for the issuance of a liquor license.

There was discussion regarding the posting, publishing and mailing of the notice of public hearing. Deputy City Clerk Andrews stated that no responses have been received.

Chairman Hall asked for any others wishing to speak either in favor or opposition of the application to come forward. There was no response and Chairman Hall closed the public hearing at 9:38 a.m.
