A BILL FOR AN ORDINANCE AMENDING SECTION 18-2-2, SUBSECTION (d) OF THE NORTHGLENN MUNICIPAL CODE REGARDING MEMBERSHIP ON THE NORTHGLENN LIQUOR LICENSING AUTHORITY

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

Section 1. Section 18-2-2, subsection (d) of the Municipal Code of the City of Northglenn, is hereby amended to read as follows:


Section 18-2-2. Licensing Authority.


(d) The Authority shall consist of five (5) citizen members who shall be residents of the City during their term of office, ~~plus one member of the Northglenn City Council who shall be a non-voting, ex-officio member.~~ The members shall be appointed by the City Council and shall serve for terms of two (2) years. The terms shall be staggered so that on even-numbered years, three (3) members shall be appointed and on odd-numbered years, two (2) members shall be appointed, with each term commencing on January 1, and terminating on December 31, of the second year thereafter, except that the members of the first authority appointed shall serve four (4) terms as follows:

- (1) Two (2) members shall serve until December 31, 2007; and
- (2) Three (3) members shall serve until December 31, 2008.


