General Mills “MyHomeTownHelper.com” Grant Fact Sheet

Background

- In January 2007, Kathy Kvasnicka (Risk Management), Deb Lawson (Recreation) and Amanda Norconk (Recreation) met with a representative from the North Metro Fire Department and Phillips AED (Automated External Defibrillator) to discuss the current technology available in AED’s and the needs of the City of Northglenn, specifically the Recreation Center.
- It was determined that it would be good practice to house 3 AED’s in the Recreation Center. One in the Senior Center, one in the pool area and one at the front desk.
- Staff training requirements include an annual renewal class and a six month refresher session.

Grant Application

- In February 2006, a grant application was submitted on-line at MyHomeTownHelper.com, asking for \$6,000.00 to fund all 3 AED’s.
- On February 23, 2007 the City was notified that an award in the amount of \$2,000.00 was granted, and a check was received in that amount.

Implementation Schedule

- The funds will be utilized to purchase one AED unit for the Senior Center, located within the Recreation Center. This unit will include a “trainer” that can be utilized to conduct the required staff trainings.
- The funds will be expended within six months, to allow time for additional funding opportunities to be sought out for the remaining two units that are slated to be placed in the pool area and at the front desk.
