

# Why We Conduct A Decennial Census

- ✓ The Constitution of the United States, Article I, Sections 2, directs that a census of the population be taken every 10 years for the purpose of reapportionment and redistricting.
- The 2020 Census counted every person living in the United States and the five U.S. territories. It marked the 24th census in U.S. history and the first time that households were invited to respond to the census online.

# **Redistricting Program**

The 2020 Census Redistricting Data Program provides states the opportunity to delineate voting districts and to suggest census block boundaries for use in the 2020 Census redistricting data tabulations (Public Law 94-171 Redistricting Data File).


### What are the P.L. 94-171 Data Files

- Public Law (PL) 94-171, enacted in 1975, directs the Census Bureau to make special preparations to provide redistricting data needed by the states.
- ✓ The PL 94-171 data were derived from questions asked on the 2020 Census questionnaire.
- ✓ For each area reported, the file provides a count of all persons and of persons 18 years of age and older.
- The data files provide population and housing tabulations (Group Quarters and Occupancy Status), for all States.




# 2020 Census Response Rates: Adams County, Colorado





### Post Enumeration

2020 Census undercounted the Black or African American population, the American Indian or Alaska Native population living on a reservation, the Hispanic or Latino population, and people who reported being of Some Other Race.

On the other hand, the 2020 Census overcounted the Non-Hispanic White population and the Asian population. The Native Hawaiian or Other Pacific Islander population was neither overcounted nor undercounted according to the findings.

Among age groups, the 2020 Census undercounted children 0 to 17 years old, particularly <u>young</u> <u>children 0 to 4 years old</u>. Young children are persistently undercounted in the decennial census.



### Post-Enumeration Survey (PES)

Estimates the population using a sample survey

### **Demographic Analysis Estimates (DA)**

Estimates the population using vital records and other data
