**List your skills, abilities, related volunteer community service and interests relevant to the City Council position.**

**Why do you want to be appointed to the City Council?**

Legislative efforts need to change to better service our real community interests and better service practical and realistic goals that benefit the diversity of our community. The lie and scam of COVID was an economic disaster to small businesses and those in poverty. The Pandemic was mishandled and a focus on restorative economy is essential.

**What vision do you have for the City of Northglenn?**

My Vision for Northglenn is one of pride, hope and a better future for all our residents. We need to strengthen our economy, provide more meaningful fair wage jobs, correct a long history of unaffordable housing and escalating costs before the 1970's. We need to clean up our education to not be the arm of partisan centered politics. Remove the political yard signs from our schools. Good fiscal management of taxes and revenue focused on the City of Northglenn and not the whims of partisan political groups. Groups tied to invasive partisan legislative effort for the state, county and other municipalities. We need city of Northglenn functions restored instead of driving miles into another city for the services and organizations that should be remained in Northglenn.



**In reviewing the City's 2022 Budget, what are you most excited about and why?**

I'm excited about fixing the budget. There is many places I have seen concerns of partisan political goals and mismanagement of funding.
