**FIRST AMENDMENT TO AGREEMENT REGARDING MUNICIPAL JUDGE  
COMPENSATION**

THIS FIRST AMENDMENT TO AGREEMENT (the "First Amendment") is made and entered into this 23<sup>rd</sup> day of May, 2022, effective as of June 1, 2022, by and between the City of Northglenn, a Colorado home rule municipality (the "City"), and AMANDA BAILHACHE ("Judge Bailhache").

**RECITALS**

The City Council previously reappointed Judge Bailhache as the Municipal Judge of the City of Northglenn pursuant to Section 6.11(b) of the City of Northglenn Home Rule Charter and Section 8-1-4(b) of the City of Northglenn Municipal Code for a term commencing on January 25, 2021, and expiring on January 31, 2023, and desires to adjust and set the salary of Judge Bailhache pursuant to the above-referenced provisions. The City previously approved Judge Bailhache's salary by Agreement dated May 20, 2019.

NOW, THEREFORE, it is hereby agreed that, for the consideration hereinafter set forth, the Parties agree as follows:

**I. TERM**

Judge Bailhache was reappointed as the Northglenn Municipal Judge by the adoption of Resolution No. 21-08 for a term commencing January 25, 2021, and continuing through and including January 31, 2023. Nothing in this Agreement shall be construed as changing the term of Judge Bailhache's reappointment.

**II. COMPENSATION**

Pursuant to Section 6.11(b) of the City of Northglenn Home Rule Charter and Section 8-1-4(b) of the Northglenn Municipal Code, the monthly fixed salary shall be five thousand two hundred fifty dollars (\$5,250.00). In addition, the City shall pay the cost of training in an amount not to exceed one thousand dollars (\$1,000.00) per calendar year and shall pay the cost of Colorado Supreme Court attorney registration dues in an amount not to exceed four hundred dollars (\$400.00) per year.

**III. OTHER COVENANTS**

Judge Bailhache's job performance, salary and other contractual issues, if any, shall be reviewed by the City Council prior to the date of re-appointment for a new term, or prior to January 31, 2023, and every two (2) years thereafter.

**IV. COMPLIANCE WITH LAW**

Nothing herein shall be deemed to create any additional terms, conditions or obligations of employment in addition to those provided for in the City of Northglenn Home Rule Charter and the City of Northglenn Municipal Code, nor is anything herein intended to change the nature of the Municipal Judge position as an appointed position under the City of Northglenn Home Rule

Charter and the City of Northglenn Municipal Code; rather, this Agreement is simply intended to memorialize the term and salary of the Municipal Judge as required by the applicable law.
