**PURPOSE:**

Staff recommends the approval of the attached Resolution allowing the Mayor to accept the Bulletproof Vest Partnership grant award.

**BACKGROUND:**

The Northglenn Police Department was awarded \$6,919.38 from the Bureau of Justice Bulletproof Vest Partnership (BVP) for reimbursement for 50% of the purchase costs for NIJ-compliant armored vests ordered between October 25, 2017 through August 31, 2019.

**BUDGET/TIME IMPLICATIONS:**

Funds to initially cover the expenses are in the Police Department Administration budget. All receipts associated with this purchase will be managed on the Bulletproof Vest Partnership website.

**STAFF RECOMMENDATION**

Staff recommends Council to approve the funding provided by the US Department of Justice.

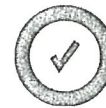
