**New Property Owner at Malley Heights**

Evergreen Marketplace LLC purchased 39,495 square feet at 450-560 Malley Drive. The strip center sits on 4.43 acres adjacent to Mile High Thrift store. The new owners purchased the property for \$4.23 Million and has plans to make major exterior renovations to the property next year.

**New Brewpub Coming to Northglenn**

Periodic Brewing is opening a second Colorado location at 2100 E.112<sup>th</sup> Avenue, Unit 1 (formerly Beer by Design). They opened their flagship location in Leadville, CO in 2015. 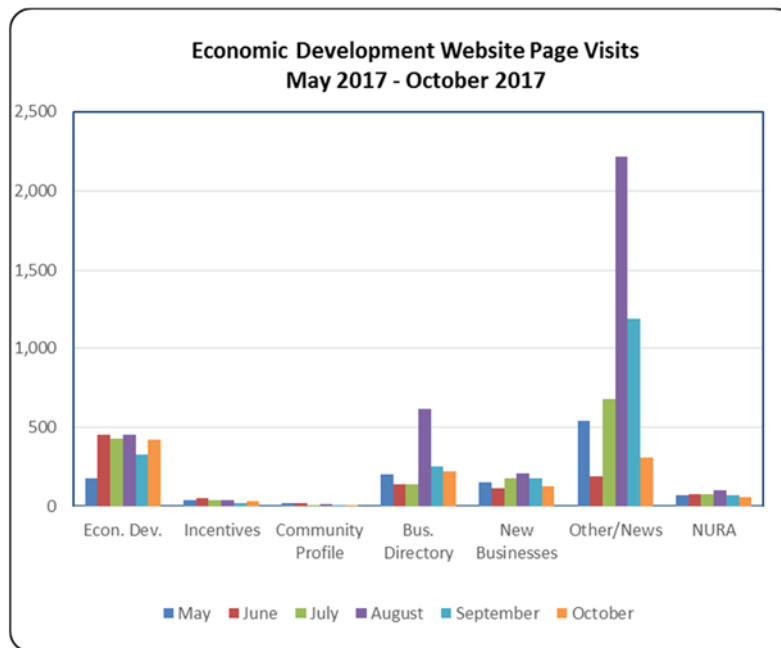

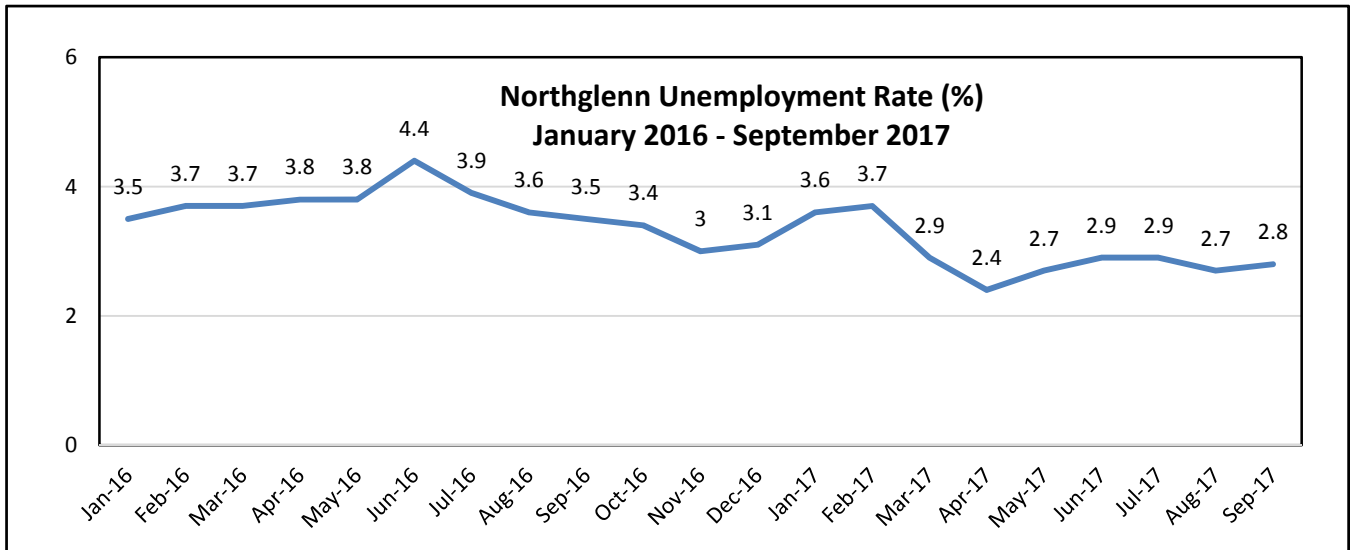
**ED Website Visits**

### Northglenn Unemployment Rate

The chart below indicates that Northglenn's unemployment rate was at **2.8%** at the end of September 2017. This rate is lower than last year at this time (3.4%). This rate is slightly up from 2.7% in August and is higher than the state average at 2.3%, and the county average at 2.4%.

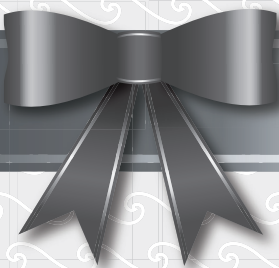
