Mayor Downing called a regular meeting of the Northglenn City Council to order on Thursday, August 25, 2011 at 7:00 p.m. in the City Hall Council Chambers, 11701 Community Center Drive, Northglenn.

Mayor Downing invited any person wishing to speak either “for” or “against” CB-1756 to come forward.

City Attorney Hoffmann provided a summary of CB-1756 and stated the ordinance would amend the Municipal Code to require that patients and caregivers who are allowed to have medical marijuana under Article XVIII, Section 14 of the Colorado Constitution and who choose to grow the medical marijuana in their home follow regulations as set forth in the ordinance.

Ms. Anita Gossett spoke against CB-1756. Ms. Gossett stated she is opposed to allowing medical marijuana to be grown in residential areas and expressed concern about the control of marijuana.

Mr. Dallas Briggs, Ward I, spoke against CB-1756. Mr. Briggs stated he disagrees with the statement that the ordinance will prevent adverse affects on neighbors and questioned the City’s ability to enforce the ordinance.

Mayor Downing called for anyone wishing to speak either “for” or “against” CB-1756 to come forward. No one came forward and the public hearing was closed.

Avenue & I-25 Bridge landscape maintenance, and concerns about safety in E.B. Rains, Jr. Memorial Park near the Skate Park.

Mayor Downing reported that applications for the Utility Assistance Program are due by September 1, 2011 for the initial grant period. Mayor Downing reported that the Historic Preservation Commission's annual garage sale went well and thanked everyone who volunteered at the event.

Council member Clyne stated she had attended Congressman Polis' Community Forum meeting and reported that she had spoken to a member of Congressman Polis' staff about the Rocky Flats issues.

Council member Carrico thanked Ms. Marge Carlow for organizing the Relay For Life event and Mr. Tom Rapp for his work with the Community Garden project.

Council member Dodge announced that the last Mayor on the Move event would be held on August 29<sup>th</sup> at 6:30 p.m. in Al Thomas Park. Council member Dodge reported that she had also attended Congressman Polis' Community Forum and stated it was interesting and well attended.
