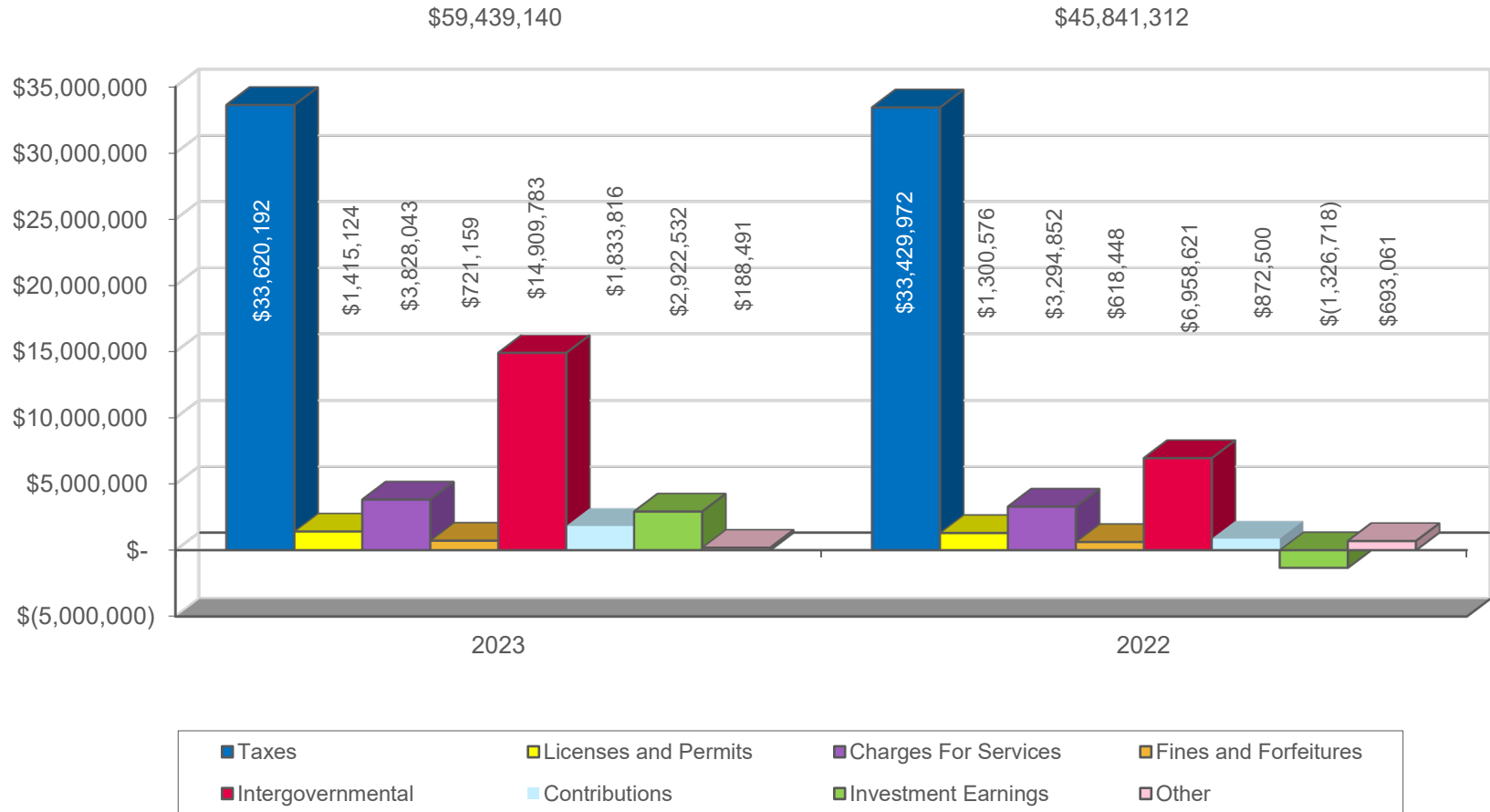

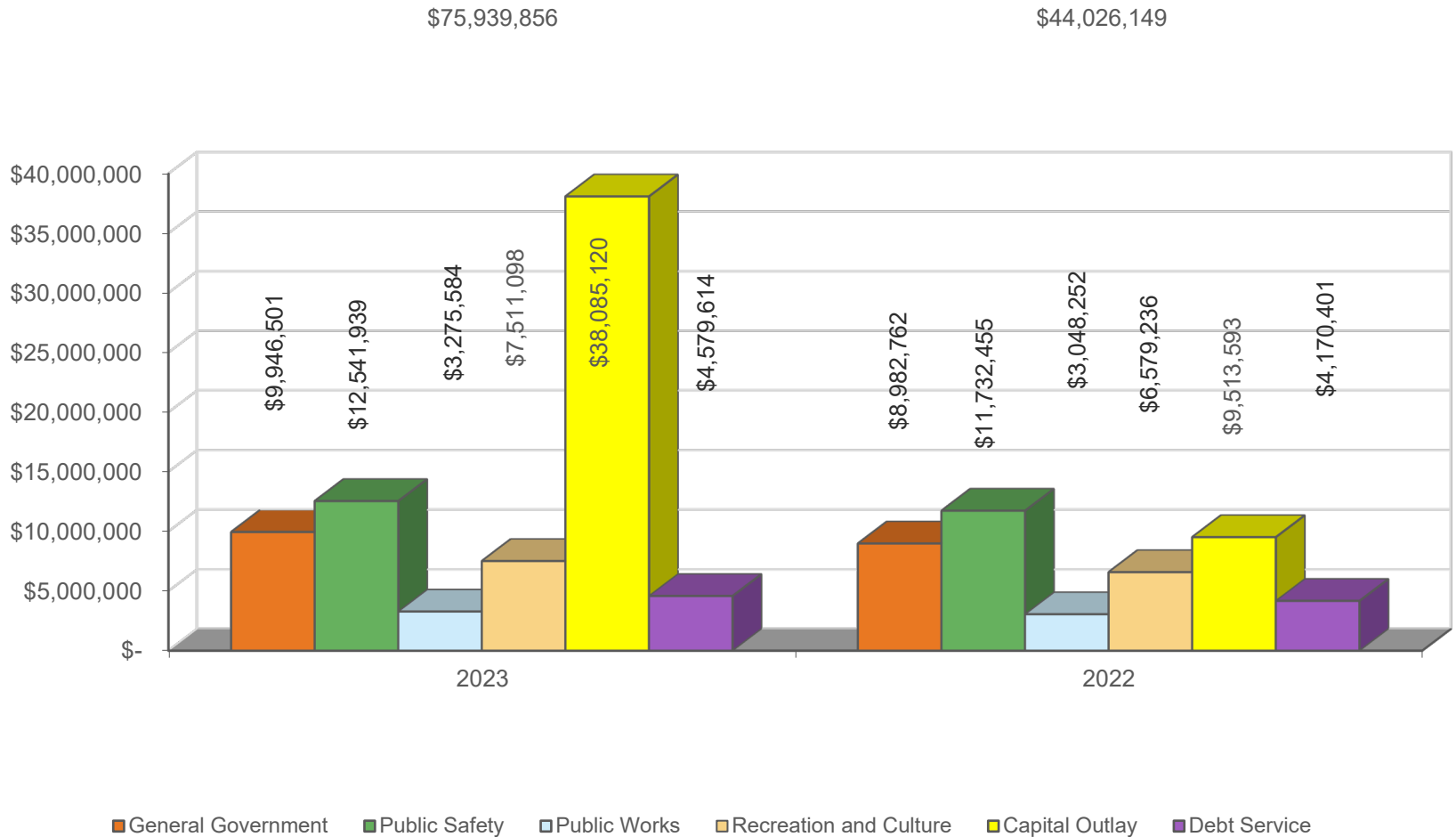

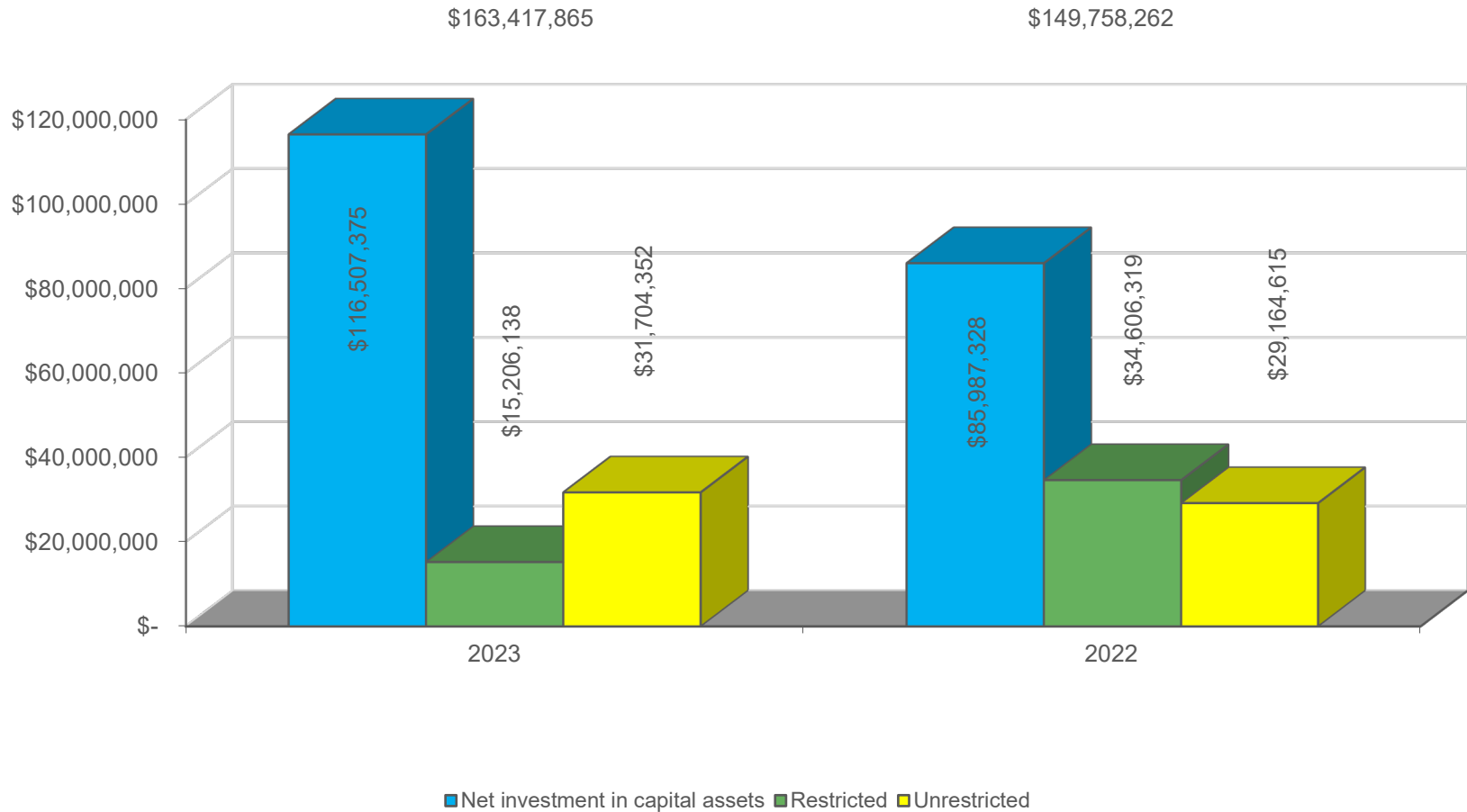
Revenue—All Governmental Funds



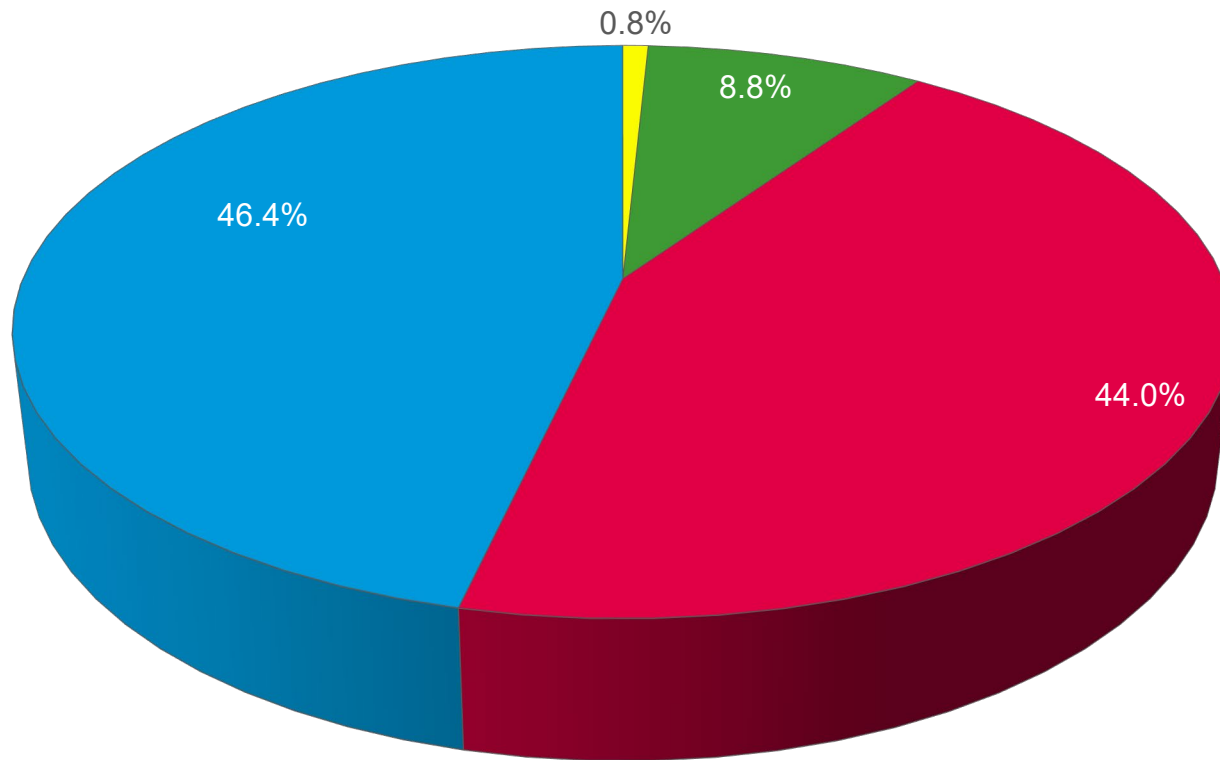
Expenditures by Function—All Governmental Funds



Net Position—Governmental Activities

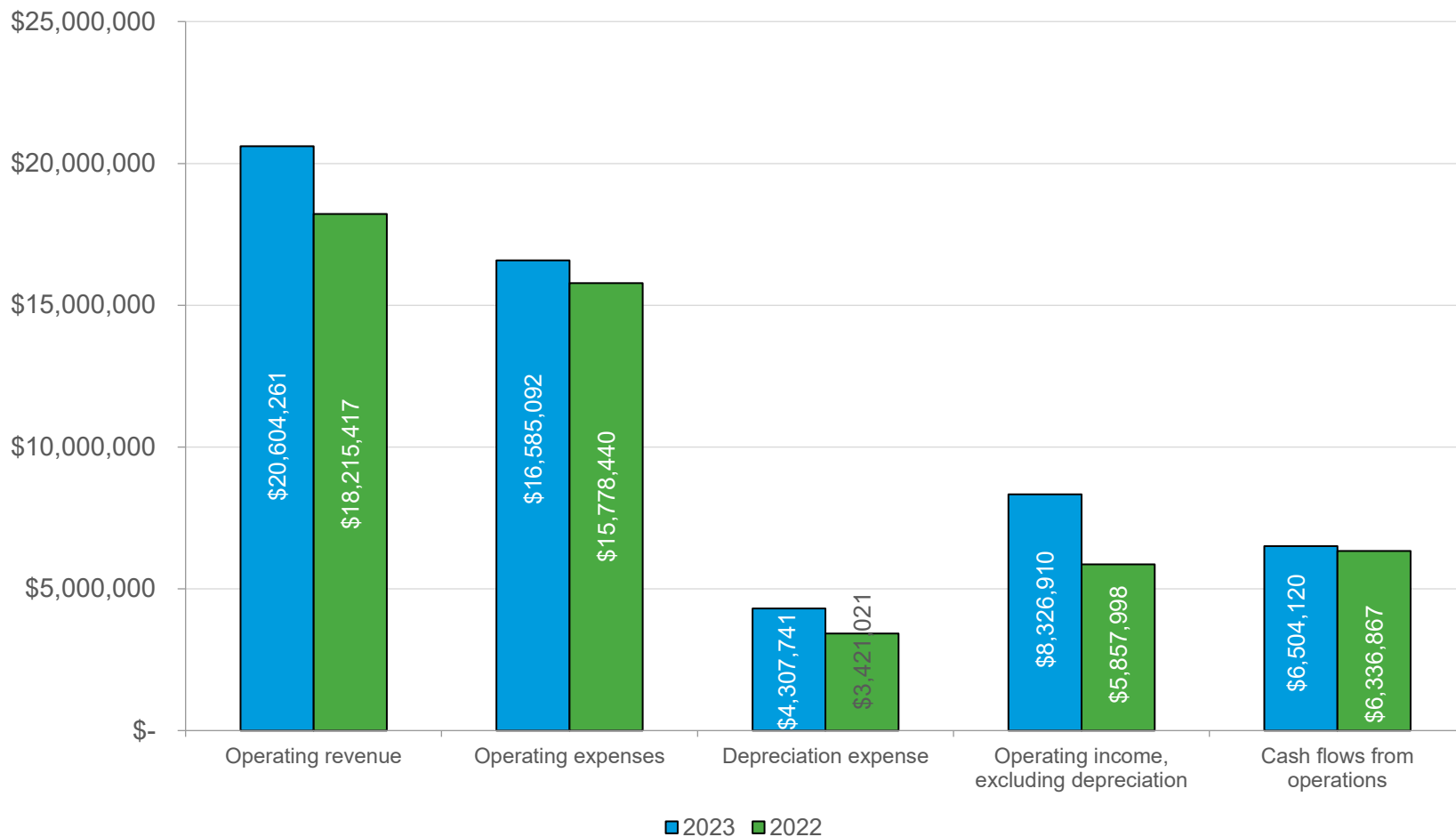


General Fund—Fund Balance as of December 31, 2023
