A RESOLUTION HONORING THE CURRENT CITY HALL BUILDING LOCATED AT 11701 COMMUNITY CENTER DRIVE

WHEREAS, the City and community of Northglenn have been faithfully served by the City Hall building at 11701 Community Center Drive, since it opened for municipal operations in 1981;

WHEREAS, the design of this building focused on providing adequate space for efficient operations and competitive services to residents. The model was to construct a quality building that would have a direct bearing on the quality of employees' work and hence the quality of the government, which eventually would determine the quality of the City;

WHEREAS, the proposal for a permanent City Hall next to the former Recreation Center was a courageous plan, consistent with the progressive leadership, needs, and aspirations of the Northglenn community;

WHEREAS, for nearly 43 years, City Council members and staff have called this building their professional home, spending countless hours in public meetings, community events, and workdays within the structure;

WHEREAS, this City Hall has been a place where residents have conducted essential business, have sought information, and have actively participated in the governance of their community;

WHEREAS, the City's progress continues and Northglenn is embarking on a new chapter in its history with a modern, first-of-its-kind City Hall facility that has been constructed on the Civic Center site, set to open on September 16th, 2024, which will continue to serve the needs of the community in innovative and forward-thinking ways;

WHEREAS, the vision for the new facility is to be a healthy, safe, and progressive place of work for City staff, and an inspiring civic resource for residents, serving as a gathering place and anchor of the Civic Center campus that fosters a sense of pride, camaraderie, and community; and

WHEREAS, today, September 9th, 2024, marks the final City Council meeting in this Council Chambers and in this City Hall building.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO THAT:

Section 1. The City Council hereby extends our deep appreciation and respect for the current City Hall building, recognizing its nearly 43 years of service as the seat of government and a pillar of the community. We honor the memories, decisions, and community spirit that were fostered within its walls, acknowledging the building's significant role in shaping the history and future of Northglenn.

Section 2. This resolution shall be kept in the official records of the City of Northglenn, ensuring that the contributions of this City Hall building to the community will be remembered for generations to come.
