Northglenn Arts & Humanities Foundation

#### **COMMUNICATIONS:**

Council member Wieneke asked staff to schedule the discussion item regarding the school crossing lights on Huron Street and Kennedy Drive for the next study session and encouraged Council to observe the crossing lights on Huron Street.

Council member Whitman reported on the Tax Assistance Program that is available at the Northglenn Senior Center on Mondays from 2:00 p.m. to 6:00 p.m. and on Tuesdays from 9:00 a.m. to 2:00 p.m. through April 14<sup>th</sup>. Council member Whitman thanked Ms. Lindy Schultz, Community Reach Center, for providing information about the organization at Coffee with the Mayor.

Council member Carrico reported the North Metro Fire Rescue District will be holding a food drive during the month of February and stated donations may be dropped off at local fire stations. Council member Carrico reported on Adams School District 12 and announced that Northglenn resident Dr. Darwin Strickland had been inducted into the Colorado High School Activities Association's (CHSAA) 2014 Hall of Fame class for his work as a physician for

high school athletes and for providing free sports physicals to district students for the past 48 years. Council member Carrico reported on the recycling presentation she attended at the STEM School and spoke about the Northglenn Community Foundation's current fundraisers, which include flower orders through ProFlowers and a Dine and Donate event on March 11<sup>th</sup> at The Glenn Bar & Grille.

Mayor Pro Tem C. Dodge reported on the recycling presentations at the STEM School. Mayor Pro Tem Dodge announced the next A Capella Series will feature the group Motive on February 20<sup>th</sup> at the D.L. Parsons Theatre, and stated the Northglenn Senior Organization (NSO) business luncheon will be held on February 27<sup>th</sup> at the Black Eyed Pea. Mayor Pro Tem Dodge reported she will be attending the Colorado Municipal League (CML) Legislative Workshop on February 12<sup>th</sup>.

Mayor Downing reported on the City's bike program and stated bicycles may be donated at any time throughout the year by contacting Ms. Jenni Murphy, Community Outreach Coordinator. Mayor Downing announced there are a number of vacancies on the City's boards and commissions and encouraged residents to attend board and commission meetings to determine if they are interesting in serving on a board.

Council member Mullica reported that members of Council and staff had testified against Senate Bill 15-040 regarding the taxation of marijuana at the State Capitol.

City Manager Pick reported House Bill 15-1007 regarding the taxation of marijuana will be heard on Wednesday at 1:30 p.m. and inquired about Council's attendance at the hearing.

City Attorney Hoffmann reported Senate Bill 15-135 regarding urban renewal will be heard tomorrow in the Senate Local Government Committee and stated he would be attending the committee hearing.
