FIFTH AMENDMENT TO AGREEMENT BETWEEN THE CITY OF NORTHGLENN AND COREY Y. HOFFMANN OF HOFFMANN, PARKER, WILSON & CARBERRY, P.C.

THIS FIFTH AMENDMENT TO AGREEMENT, made this _____ day of _____, 2024, to be effective January 1, 2025, by and between COREY Y. HOFFMANN of Hoffmann, Parker, Wilson & Carberry, P.C. (hereinafter "HPWC"), and the CITY OF NORTHGLENN, COLORADO (hereinafter called the "City").

WHEREAS, on October 12, 2006, the City Council approved the Assignment of that Agreement for legal services dated June 12, 2003 (the "Original Agreement");

WHEREAS, the parties further amended the Original Agreement by the First, Second, Third and Fourth Amendments thereto regarding the hourly rate paid for such legal services; and

WHEREAS, the parties now desire to further amend Section 7 of the Original Agreement regarding the hourly rate paid for such legal services as set forth below.

NOW, THEREFORE, the parties agree to amend Section 7 to read as follows:

7. Effective January 1, 2025, the City shall pay HPWC at an hourly rate of ~~\$205.00~~ \$225.00, payable in monthly installments.

Except as amended above, the provisions of the Original Agreement as amended are hereby ratified by HPWC and the City.
