SIXTH AMENDMENT TO EMPLOYMENT AGREEMENT

THIS SIXTH AMENDMENT TO EMPLOYMENT AGREEMENT (the "Sixth Amendment") is made and entered into this 24th day of February, 2025, retroactive in part to August 20, 2024, and retroactive in part of December 14, 2024, as described below, by and between the City Council of the City of Northglenn, State of Colorado, a municipal corporation (the "City"), and Heather M. Geyer (the "City Manager"), both of whom understand as follows:

RECITALS

A. The City and the City Manager entered into that Employment Agreement dated July 23, 2018 (the "Original Agreement"), by which the City employed the services of Heather M. Geyer as City Manager of the City of Northglenn, Colorado.

B. The City and the City Manager entered into that First Amendment to Employment Agreement dated July 22, 2019 (the "First Amendment").

C. The City and the City Manager entered into that Second Amendment to Employment Agreement dated November 9, 2020 (the "Second Amendment").

D. The City and the City Manager entered into that Third Amendment to Employment Agreement dated September 20, 2021 (the "Third Amendment").

E. The City and the City Manager entered into that Fourth Amendment to Employment Agreement dated January 9, 2023 (the "Fourth Amendment").

F. The City and the City Manager entered into that Fifth Amendment to Employment Agreement dated October 23, 2023 (the "Fifth Amendment").

G. The City and the City Manager desire to further amend the Original Agreement as amended, as set forth hereinbelow.

NOW, THEREFORE, in consideration of the mutual covenants herein contained, the parties hereto agree as follows:

1. The first paragraph of Section 3 as amended by previous amendments is further amended to read as follows:

3. Compensation. Retroactive to August 20, 2024, the base salary to be paid to Heather M. Geyer for her services as City Manager shall be increased by three percent (3%) to the amount of Two Hundred Twenty-Two Thousand, Nine Hundred Fifty-Three Dollars (\$222,953) annually, which shall be paid periodically in the same manner as other employees of the City are paid. Effective December 14, 2024, the base salary to be paid to Heather M. Geyer for her services as City Manager shall be increased by an additional two percent (2%) to the amount of Two Hundred Twenty-Seven Thousand, Four Hundred Twelve Dollars (\$227,412) annually, which shall be paid periodically in the same manner as other employees of the City are paid. Such salary may be increased by appropriate action of the City

Council at any time. This agreement shall be automatically amended to reflect any salary adjustments that are provided or required by the City's compensation policies. Consideration shall be given on an annual basis to increase compensation.

2. Entire Agreement. This Sixth Amendment, along with the Original Agreement, the First Amendment, the Second Amendment, the Third Amendment, the Fourth Amendment, and the Fifth Amendment constitute the entire Agreement between the City and the City Manager. None of the provisions of this Agreement may be amended, modified or changed, except via an additional written Amendment.
