SPECIAL PRIVATE OCCASSION PERMIT APPLICATIONS:

Victoria Brown Deputy City Clerk Andrews provided a summary of the application

submitted by Victoria Brown for a special private occasion permit to allow 6% beer and wine to be consumed on August 7th from 3:00 p.m. to 8:00 p.m. at E.B. Rains, Jr. Memorial Park,

Tumbleweed and Sage Brush Pavilions for a family reunion.

There was discussion regarding the proximity of the pavilions to the playground. Ms. Brown stated that she has experience serving alcohol as she was previously a bartender. All alcohol beverages will remain within the permitted area and she personally knows

each guest.

NEW LIQUOR LICENSE APPLICATION – PUBLIC HEARING:

Fresh Start Northglenn, LLC d/b/a First Watch Restaurant,

A Daytime Café

Deputy City Clerk Andrews provided a summary of the application for a new hotel and restaurant liquor license application submitted by Fresh Start Northglenn, LLC d/b/a First Watch Restaurant, a Daytime Café. It was noted for the record that notice of the public hearing on the application was mailed to 1581 businesses and residences within a one-half mile radius neighborhood boundary, posted on premise at 100 E. 120th Avenue #G-140, and published in the Northglenn Thornton Sentinel on July 23, 2015.

As there were no objections to the jurisdiction of the Northglenn Liquor Licensing Authority or the prescribed procedure of the hearing, Chairperson Foster opened the public hearing.

Mr. Jon Stonbraker, present on behalf of Dill, Dill, Carr, Stonbraker, & Hutchings, P.C., applicant's legal counsel, introduced the application and requested that the neighborhood survey that was conducted by Liquor Licensing Professionals, LLC on behalf of the applicant be admitted to the record. The survey reported that 100% of residents and businesses surveyed expressed support for a new hotel and restaurant liquor license to be issued for First Watch Restaurant, a Daytime Cafe at 100 E. 120th Avenue #G-140. The Authority voiced no objection to the survey and it was accepted into the record.

Mr. Stonbraker called Mr. Richard W. Boyle to testify regarding the application. Mr. Boyle stated that he is a managing member of Fresh Start Northglenn, LLC. Mr. Boyle briefly discussed his background, stating that he has more than 30 years of experience in restaurant management. Mr. Boyle stated that there has not been any material change to the application since the date of filing and explained that the premises is leased by Fresh Start Northglenn, LLC. The business is open from 7:00 a.m. to 2:30 p.m. and serves breakfast, brunch, and lunch that is prepared fresh daily. Mr. Boyle stated that there is a patio on premises and signage will be posted to state that all alcohol beverages must remain within the licensed premises. With regard to liquor service policy, all employees will be TIPS certified before the service of alcohol begins at the restaurant. Identification will be checked for anyone ordering alcohol that appears to be under 30 years of age. No vertical identification will be accepted. The alcohol menu will feature Bloody Mary's, Mimosas, and Irish Coffees. There were no further questions of Mr. Boyle.

Mr. Stonebraker indicated that Mr. Robert Schwarz, the on-site manager, was also present and sworn in to testify if necessary. There were no questions for Mr. Schwarz.

Chairperson Foster called for anyone else wishing to speak either in favor or opposition of the application to come forward. Receiving no response, Chairperson Foster declared the public hearing closed.

MOTION TO PASS

Ms. Rikhoff **MOVED** and it was **SECONDED** by Ms. Whitman to approve the liquor license application filed by Fresh Start Northglenn, LLC d/b/a First Watch Restaurant, a Daytime Café.
